Dealers must have and display a valid North Carolina Sales Tax Certificate. All retail sales are subject to N.C. Sales Tax. Any Dealer offering counterfeit, altered, or other spurious material will be subject to expulsion from the show without recourse. Dealers may not move tables without permission of the Bourse Chairman. Dealers must use only UL commercial grade grounded extension cords. Unless prior arrangements have been made, tables that are not occupied by 3pm Friday or are abandoned by 3pm Saturday revert to the NCNA. This application releases the NCNA and The Cabarrus Arena and Events Center and their Officials from any and all indemnity for loss during or subsequent to the event.**
